# 7 Miscellaneous

### 7.1 Standards of the ECSC, WCCC & WCSC

The alarming lack of the organizers interested in hosting the yearly WFCC events has opened the question of the standards of ECSC, WCCC & WCSC and how to achieve them. Julia Vysotska shared her fresh experience about many different aspects the WCCC organizers should take care of (marketing, finances, communication with hotels and embassies, running the website, engaging the judges for solving and composing, etc). She suggested the delegates should be deciding what level of organization they want. According to that, an international group of 4-5 organizers could be gathered, with some part of the expenses covered by the WFCC, not by the hosts. During the discussion it was also suggested that creating a handbook for the WFCC organizers would be very helpful. However, no decision was made.

## 7.2 New WFCC projects and contributions of volunteers

Abdulla Ali Aal Barket presented the contributions of UAE to the WFCC in latest period: a yearly support of 5,000 Euros; an official WFCC bank account opened in UAE after a long process; a permanent work for the WFCC social media (Facebook, Instagram, LinkedIn, X & YouTube); opening and running WFCC account on the Chess-Results server; supporting the first FIDE & WFCC championships for cadets and juniors in Italy and Brazil; running WFCC Zoom Meetings; opening a WFCC office in the new building of the Fujairah Chess & Culture Club, etc. Marjan Kovačević thanked Mr. Aal Barket for the outstanding contributions and described how the UAE activities in chess composition have improved the WFCC cooperation with the FIDE officers.

Dinu-Ioan Nicula presented the progress of the project he was leading in cooperation with the WFCC president to establish regular solving events in the context of FIDE World Championships for cadets (U8, U10 & U 12 years) and juniors (U14, U16 & U18). The first such events were

planned for November 2024 in Italy and Brazil. Mr. Nicula stressed the important support got from Chair of the FIDE Events Committee Akaki Iashvili and the FIDE Executive Director Victor Bologan. He also thanked the volunteers who gave important contributions: Ilija Serafimović prepared instructions with examples, Anirudh Daga organized free online lessons for juniors around the world, while Mohammad Alhallak created registration forms and entered all the data into the Chess-Results server.

Coordinator of the Calendar of Composing Tournaments Kenneth Solja informed about materials from more than 100 tourneys he posted between November 2023 and August 2024. He thanked llija Serafimović and Julia Vysotska for the initial support to the project and invited everybody to contribute more actively. Mr. Solja pointed at main issues he was facing (Annex 1), like getting PDF files instead of the links to already posted files, or getting only the announcements, and not the awards.

As the initiator and the main organizer of the Online Solving Challenge for Youth, Brian Cook was very satisfied with technical side of the series of six online competitions, each including a "Classical" and a "Blitz" round. The OSCY Team was running the competitions with a great enthusiasm and their main goal to achieve in the future is to enlarge the number of youngsters interested in solving. The full report and statistical review is in the Annex **2**.

The President expressed especial gratitude to Julia Vysotska and Harry Fougiaxis for the personal support and their help in the previous period. He also thanked many volunteers who enthusiastically suggested taking over different duties for the well-being of the WFCC: Brian Cook, Ian Watson, Vlaicu Crişan, Miodrag Mladenović (OSCY); Kenneth Solja (Composing Calendar); Marcos Roland (WYCSC and promotion in Brazil); Bjørn Enemark, Harry Foigiaxis, N. Shankar Ram, Nikola Stolev (FIDE Album Points List & Errata List); Roland Ott, Axel Steinbrink (ISC Archive); Arvydas Mockus, Andy Ooms, Bohumil Moravčik (ISC 2024); Anirudh Daga (WFCC social media, free online lessons); Mohammad Alhallak (WFCC social media, Chess-Results, FIDE solving events); Gady Costeff (FIDE Centenary book).

## 7.3 Proposals

## 7.3.1 FIDE supported projects

The president Marjan Kovačević informed the delegates about the difficulties the FIDE World Cup in Composing had been facing since 2023. This FIDE Special Project, initiated by Andrey Selivanov and organized by his team since 2010, was using the FIDE yearly budget of 10,000 Euros in the period 2019-2023. The sanctions on Russia prevented smooth realization in 2023 and 2024, and Mr. Selivanov suggested WFCC to form a commission to take it over, with him as the president. WFCC Presidium and several other delegates didn't support such a proposal. The remaining options were either to give up this part of the FIDE support and to risk not having it anymore, or to ask FIDE officers if WFCC may use the planned budget for other FIDE related special projects in 2024.

The FIDE Executive Officer Victor Bologan kindly offered to reallocate the same budget to the three new FIDE supported projects in 2024: FIDE Youth Solving Events, FIDE Album, and a booklet celebrating FIDE Centenary with selected problems/endgames from the period 1924-2024. The first two projects were already on the way, and caused no additional efforts. Gady Costeff generously offered to prepare the whole material for a booklet with 100 endgames 1924-2024,

and to edit it in a very short time, while Peter Gvozdják took over the jobs around publication and shipping. See: https://www.wfcc.ch/one-endgame-study-in-a-thousand/.

The delegates were asked to make proposals about the future of the FIDE World Cup, including its format, budget, and the organizing team, for an online Meeting before the end of 2024. The meeting was held on 25<sup>th</sup> October via Zoom connection, organized and executed by WFCC secretary Mohammad Alhallak, with delegates or deputies of 28 countries, among 35 participants. Out of several options for the World Cup yearly budget (in Euros: 10,000, 8,000, 6,000, 5,000, 3,000, 2,000 and zero) most votes were given to: 5,000 (7), 3,000 (7) and 2,000 (7), with four votes for 10,000 and three for no budget at all. In the 2<sup>nd</sup> round, more than half of delegates (15) supported the budget of 3,000 Euros, 8 delegates voted for 5,000 and three for the middle option of 4,000 Euros.

The decision to significantly reduce the FIDE World Cup budget in 2025, and to allocate remaining 7,000 Euros to other FIDE related projects (4,000 Euros to solving events in the context of FIDE championships for cadets and juniors, and 3,000 Euros to FIDE Album Project), opened the question of financing the demanding duties of the World Cup Director 2025. In an email exchange on the topic before the session (the exchange included 12 delegates and 10 active composers), Torsten Linss generously offered to volunteer as the WC director in 2025, and this was accepted with gratitude. Discussion on the World Cup beyond 2025 and suggestions to revive the tradition of FIDE Olympic tourneys in even years were postponed. ## 7.3.2 Proposals concerning the war between Israel and Hamas

Referring to the victims in Gaza during the war between Israel and Hamas, Bjørn Enemark proposed the WFCC should apply the same sanctions on Israel as on Russia and Belarus (see <u>WCCC</u> <u>2024 Agenda</u>). After several discussions and presenting opposing views, the proposal was put on voting and rejected, with 4 votes in favour, 17 votes against and 7 abstentions.

## 7.3.3 CFR proposal to hold WCCC 2025 in Moscow

The only bid for the WCCC & WCSC 2025 came from the Chess Federation of Russia Executive Director Alexander Tkachev. Delegates expressed negative attitude toward organizing a competition in a country under sanctions. More negative reactions followed the speech of Georgy Evseev in support of the proposal, and some delegates left the meeting in a sign of a protest. The proposal was then put on voting and rejected, with no vote in favor, 25 votes against, and 3 abstentions. For the Online Meeting on 25<sup>th</sup> October 2024 Thomas Maeder made a proposal to WFCC Presidium to suspend Russia's delegate Georgy Evseev because of his statement about situation in Ukraine. The request by Mr. Maeder, the transcript of the mentioned speech of Mr. Evseev, and the statement by the Presidium on the matter were presented in the <u>Agenda of the Online Meeting</u>. Presidium recommended Mr. Evseev to reconsider his statement and asked WCCT Committee to discuss the compatibility of Mr. Evseev as the spokesman of the committee. No measures or sanctions in such a case have been predicted by the WFCC Statutes. In a short speech, Mr. Evseev said his federation didn't allow him to make any political comments on the matter. At the same time, he decided to step down from the positions of the WCCT Committee spokesman and the FIDE Album Committee member.

Marjan Kovačević suggested that in the current situation, with four WFCC member countries involved in wars, the WFCC needs to establish an Ethics Committee that may start working on a WFCC Ethics Codex. Honorary Presidents Klaus Wenda and Harry Fouigiaxis accepted to be the members of the working group, together with Narayan Shankar Ram. Later on Roberto Osorio and Axel Gilbert joined the group, while Mr. Shankar Ram accepted the role of the committee spokesman.

# 8. Reports and Discussion

## 8.1 Studies Committee

Spokesman Steffen Slumstrup Nielsen reported there were no topics to discuss except the Finish proposal to adjust FIDE Album points for studies and to reduce it from 1.67 to 1 point as in all other sections. Committee saw no reason to change the long lasting rule at that moment. They claimed there was no inflation among study grandmasters, with only 11 living GMs, and only five new study GMs in the last 20 years. The argument put by Neal Turner, who suggested the change of points, was that computer had made composing an endgame much easier than when the 1.67 Rule was accepted. In a long discussion many opposing arguments were presented, but the overall feeling was that the topic needs to be thought over during a longer time and the voting was postponed.

## 8.2 Solving Committee

## 8.2.1 International Solving Contest (ISC) 2024

The 20th ISC took place on 21<sup>st</sup> January 2024, with 669 solvers from 46 countries. Central controller Arvydas Mockus thanked all the local controllers in 41 tournaments held in 26 countries, as well as the following: Borislav Gadjanski for his daily updates of the results on the MatPluswebsite, Luc Palmans for checking Cat1 solving sheets, Andy Ooms who checked Cat2, and Bohumil Moravčik who helped a lot with the selection of the problems. President thanked Mr. Mockus for volunteering to take over this demanding duty and for realizing it in a very short time. ## 8.2.2 European Chess Solving Championship (ECSC) 2024

17<sup>th</sup> ECSC was held in Hagen (Germany) on 20<sup>th</sup> and 21<sup>st</sup> April 2024, with 15 teams and 71 individuals. As one of the ECSC directors, together with Luc Palmans, Axel Steinbrink was reporting to the Assembly. The Polish team was on the top once again, ahead of Serbia and Lithuania. Teams – final ranking

Kacper Piorun became the individual champion, with a slightest advantage over Bojan Vučković, and Jakub Marciniszyn added another medal to the Polish Trophy-room.

The winner of the Hagen Open was Piotr Murdzia, ahead of Kacper Piorun and Kari Karhunen. Mr. Steinbrink also paid attention to one excellent result of Ms. Audrey Kueh – the 2<sup>nd</sup> place in Retro Solving.

## 8.2.3 World Chess Solving Championship (WCSC) 2024

Ryszard Królikowski was the director of the 47<sup>th</sup> WCSC in Jūrmala, on 30<sup>th</sup> and 31<sup>st</sup> July 2024. His assistant Axel Steinbrink gave report on the championship that attracted 19 teams and 82 individuals. Great Britain managed to replace the dominant Polish team on the top of the podium, with the same number of points but with better time. As Mr. Steinbrink noted, the previous time the

winner was decided on tiebreak was 16 years ago, and also in Jūrmala, when Russian team was faster than the one from Germany. The same as the British team, Israel had two seniors in the team, who were most deserving for reaching the 3<sup>rd</sup> place.

### <u> Teams – final ranking</u>

Individual competition brought a double crown to Kacper Piorun, after winning the ECSC 2024. John Nunn had only one point less and his better time had no importance in this case. Nikos Sidiropoulos made a nice surprise winning the bronze medal.

The same as in Hagen Open, Piotr Murdzia was better than his countryman Kacper Piorun in the Jūrmala Open. This time he was sharing the 1<sup>st</sup>-2<sup>nd</sup> place with Boris Tummes, while Mr. Piorun was in the 3<sup>rd</sup> place.

## 8.2.4 World Solving Cup (WSC) 2023/2024

The victories in the Open tournaments of ECSC and & WCCC allowed Piotr Murdzia to overcome Eddy Van Beers (109:108) in the exciting final stage of the year-long World Solving Cup 2023/2024. The bronze medal went to Martynas Limontas who remained traditionally successful in the WSC cycles.

## Final ranking

The busiest solving judge Axel Steinbrink replaced the WSC Director Roland Ott in reporting. President thanked Mr. Ott for his tireless work for the WSC, and the assembly greeted the winners of all solving competitions in 2024.

## 8.2.5 Other Solving Matters

Spokesman Marek Kolčak reported on several different topics discussed by the committee. The proposals on how to treat a virtual threat (in the guidelines for solving directors) and the proposals touching wildcards for ECSC &WCSC (senior team championships and wildcards for previous medallists) were left for future discussion, the same as the proposals to re-establish Olympic solving tournaments. The proposal from Dinu-Ioan Nicula to shift the tournaments with late results to the next Rating List wasn't supported by the committee. Instead, the organizers will be asked to avoid holding tournaments at the latest dates of the rating periods (Annex 3). Point 6 of the Rules for World Solving Cup was reformulated this way: The WSC season is generally the period between two WFCC congresses. Therefore, the new WSC season usually starts after the WFCC congress, but not later than 1 September. This rule change is intended to prevent from having to propose exceptions when congresses are scheduled at a later date (Annex 3). Some irregularities in the ISC 2024 were registered by the committee, especially the photos of the solvers posted in social media before the competition was ended in other areas. There was a long discussion about it, but no notable impacts on the results were identified. An additional rule was accepted to forbid money prizes in ISC in order to reduce the danger of irregularities. There were 16 votes for the proposal, 9 against, and 3 abstentions.

## 8.3 FIDE Album Committee

Spokesman Harry Fougiaxis reported that all the material for the current Album 2019-21 were on the editorial site that Peter Gvozdják and his team had created. Indexing was in progress and there was a clear sign that the album will be available in the next Congress. It was stated, with regrets, that the FIDE Album Errata Project had got too few contributors.

The old proposal made by N. Shankar Ram and Vlaicu Crișan in 2022 to create a new fairy group G3 for help-self play problems of all kinds, was accepted after voting: 21 in favour, 2 against, 5 abstained. The percentages of selected problems will take into consideration the whole Section G. The list of judges for Album 2022-24 was finalized, and the <u>Announcement</u> prepared:

- Announcement: March 1, 2025
- Closing date: September 1, 2025
- Submission of entries to the judges: December 1, 2025
- Reports by the directors and results: December 1, 2026
- Submission of selected entries to the editor: February 1, 2027
- Indexing, typesetting, printing: August 1, 2028

#### 8.4 WCCI Committee

Spokesman Marco Guida reported the preparations for WCCI 2022-24 were mostly finished in 2023, and only a few changes and additions in the list of judges and members of the Supervising Panel were added in 2024. Because of inactivity of some earlier members, the composition of the committee was reduced to five members, with an "open invitation" to Harry Fougiaxis, whose contribution has proven to be always extremely valuable. The WCCI Committee briefly discussed the future of WCCI beyond the 2022-24 cycle: is a change required (as it is the opinion of the Spokesman of the WCCI Committee), or should the "status quo" be maintained? Some initial discussion on pros and cons of various options has taken place, showing a diversity of opinions among WCCI Committee Members on the need for a change and on the viability of the various options. In front of such diversity of opinions, the decision has been therefore to place the topic on hold, ready to restart discussions as soon as time for change will be more mature. The final decisions about the future of WCCI should be made before the beginning of the relevant WCCI cycle. President praised again the work of this small but highly active committee. The full report of the committee meeting is in the Annex **4**. The <u>WCCI 2022-24 Announcement</u> was ready to be posted as planned:

#### 8.5 WCCT Committee

As the spokesman Georgy Evseev was present only online, and the report of the committee (Annex **5**) was presented by Kjell Widlert. The 12. WCCT was planned to be announced in the spring of 2025, but some essential elements were still missing: the Director, themes and judges. The committee had discussed whether countries with sanctions should be allowed to make a preliminary registration. The majority of the committee felt that there was no need for this: if and when the sanctions are lifted, a quick decision can be taken to allow those countries to take part. As the latest proposal to change the score calculation came very late, the committee couldn't recommend any change (and therefore probably not for the 12. WCCT). The committee will return to the question next year.

#### 8.6 Youth Committee

The meeting of the largest committee gathered 11 out of 15 members, whose work was going on throughout the year. The main topic was reviewing the <u>8th Youth Chess Composing Challenge</u> that attracted 37 young composers born 2001 and later, from 13 countries: Austria, Canada, France, India, Israel, Latvia, Poland, Romania, Russia, Serbia, Slovakia, Ukraine, and USA. The results per sections: <u>Section A</u> (thematic #2), <u>Section B</u> (Endgame studies), <u>Section C</u> (all kinds of problems except studies). The feeling of the YCCC Team was that YCCC-8 had inspired many mature compositions on a higher overall level than previous years. It is expected that popularity and quality of YCCC should grow, since juniors from at least half of the WFCC member countries haven't joined these composing competition yet. The general YCCC-8 standings, in the competition for the five 500 Euros vouchers to take part in the WCCC 2025 (or ECSC 2025) was: 1. Ural Khasanov (Russia), 2. Ilija Serafimović (Serbia), 3. Benjamin Defromont (France), 4. Joachim Hambros (Austria), 5. Itay Richardson (Israel), 6. Dylan Schenker (USA), 7. Andrii Sergiienko (Ukraine), etc.

The committee expressed gratitude to Brian Cook and his team for the excellent organization of the OSCY 2024. Piotr Górski and Kacper Piorun announced readiness to support the FIDE youth and cadets solving championships, and Milan Petras presented preparations for the European Youth Chess Solving championship in Prague, organized by the European Chess Union.

#### 8.7 Computer Matters Committee

Spokesman Thomas Maeder reported that there were no topics of discussion this year and the committee did not meet.

#### 8.8 Codex Committee

There was nothing to report from the Codex committee.

#### 8.9. Qualification Committee

Spokesman Dinu-Ioan Nicula reported as follows:

After an individual analysis made by each member and then in common, the Qualifications Committee has decided unanimously that the next titles are fulfilling the conditions to be awarded by WFCC:

Grandmaster of the FIDE for Chess Compositions: Steffen Slumstrup Nielsen (DNK)

International Master of the FIDE for Chess Compositions: Karen Sumbatyan(RUS)

**FIDE Master for Chess Compositions:** Sergiy Didukh (UKR), Daniel Keith (FRA), Jan Sprenger (GER), Aleksandr Stavrietsky (RUS)

International Solving Master of the FIDE: Mihnea Costachi (ROU), Jakub Marciniszyn (POL)

FIDE Solving Master: Roman Brick (USA), Lev Glanzspiegel (ISR)

International Judge of the FIDE for Chess Compositions: Marcin Banaszek (GER, selfmates), Viktoras Paliulionis (LTU, helpmates)

All these titles were accepted by the assembly by acclamation.

#### 9 Financial Report, Balance Sheet, Auditor's Report, Budget

In the name of the treasurer Abdulla Ali Aal Barket, Julia Vysotska presented to the Assembly the financial report 2023-24 (Annex **6**) with the budget for 2024-25 (Annex **7**) and the balance sheet of 30.06.2024 (Annex **8**). Ms. Vysotska explained why the balance sheet presented much better financial situation than in the Batumi WCCC 2023. The change of bank account resulted in postponement of the FIDE regular budget and the delayed transfer of 6,000 Euros for two years allowed covering some postponed expenses. The projects of the FIDE and the Fujairah Government were presented as conditional support, and not as the WFCC income. They ask for certain expenses, and some of them will be realized with a delay of a year or two.

The auditor, Marco Guida confirmed that he had reviewed the documents and found them in order. The financial report and budget were accepted in a vote: 22 for, 2 abstentions.

#### **10 Election of Auditors**

The current auditor, Marco Guida and the reserve auditor, Johan de Boer were proposed and were accepted (no formal voting).

#### **11 Future Meetings**

The deadline for 2025 bids was extended till 5<sup>th</sup> October 2024, and the decisions were made in an Online Meeting, on 25<sup>th</sup> October 2024. The only bid for ECSC 2025 came from Greece and was accepted by acclamation. The 18<sup>th</sup> ECSC was announced to be held in the University of Athens, from 25<sup>th</sup> to 27<sup>th</sup> April 2025.

During discussion about the three bids for WCCC & WCSC 2025, Hannu Harkola expressed an opinion that according to the Statutes only the bids from member countries should be taken in consideration, and not the Montenegro bid. Since there were exceptions before (Turkey ECSC 2008 and Montenegro ECSC 2014), the case was put on voting, and the bid wasn't accepted, with 15 votes against it, 8 for, and 5 abstentions.

In the competition between two remaining candidates, Estonia (Tallinn) and Romania (Alba Iulia), the latter bid got 20 votes, and the former 7, with 1 abstention. Thus, the 67<sup>th</sup> WCCC and 48<sup>th</sup> WCSC will be held in the historical venue Alba Iulia, from 5<sup>th</sup> to 12<sup>th</sup> July 2025. It will be the first ever Congress in Romania, in the year when the Romanian Chess Federation celebrates its centenary.

## **12** Conclusion

The President thanked the delegates and the spokesmen of committees for their work during the week. He congratulated the organizers for providing excellent facilities and wonderful conditions, which contributed to a memorable congress. Then he declared the meeting closed.

# Change of Rule 6 of the Rules for the World Solving Cup (WSC)

### current:

A season of the WSC is a period between the two WFCC congresses.

#### new:

The WSC season is generally the period between two WFCC congresses. Therefore, the new WSC season usually starts after the WFCC congress, but not later than 1 September. **Reason:** 

This rule change is intended to prevent us from having to propose exceptions when congresses are scheduled at a late date.

The Solving Committee does not support Dinu-Ioan Nicula's proposal as it does not cover possible cases arising from the deadline for the submission of results according to the rules (10 days for multiple-locations tournaments / 5 days for all other rated tournaments).

After a discussion about priorities, the members of the Solving Committee consider it more important to record all tournaments of the past quarter than to publish the new rating list on the first day of the new quarter.

However, from now on we will ask tournament organisers of solving tournaments that take place just before or at the end of a quarter to submit the results quickly.

We will also discourage organisers of multi-site tournaments from scheduling them towards the end of a quarter.

## 1. Update on the Final List of Judges for WCCI 2022-24

In comparison to the list already agreed upon and presented to the Presidium and to all Delegates in Batumi, only 2 changes have occurred:

- Section E– Mr. Janos Csak has withdrawn due to heath issues and has been replaced by Mr. Harry Fougiaxis;
- Section F Mr. Gennady Kozyura unfortunately deceased and has been replaced by Mr. Sergiy Borodavkin.

Additionally, Reserve Judges has been appointed for:

- Sections A (Piotr Novitsky UKR),
- Section D (Steffen Nielsen DNK),
- Section E (Ofer Comay ISR)
- Section H (Andrey Frolkin UKR).

We do not feel necessary at this stage to appoint reserve judges for the other Sections.

No objection has been received and the list (which is included in ANNEX in the text of the Announcement) is deemed to be final.

#### 2. Planning of the WCCI 2022-24

We discussed and decided the following timing for the WCCI 2022-24:

- a. December 1<sup>st</sup>, 2024: Announcement will be published on WFCC Web Site
- b. January 20<sup>th</sup>, 2025: Deadline for Submission of entries to the Director

- c. By February 1<sup>st</sup>, 2025: Entries and spreadsheets for the scores sent by email to the Judges
- d. By June 1<sup>st</sup>, 2025 the latest: Judges' marks sent to the Director
- e. June 15<sup>th</sup>, 2025: Provisional results sent to the Supervising Panel and to the WFCC President
- f. June 30<sup>th</sup>, 2025: Final results published on the WFCC site

No objection has been received and the schedule has been approved.

## 3. WCCI 2022-24 Announcement

The ANNEX includes the complete text of the Announcement (including list of Judges, Schedule and composition of the Supervising Panel) that has been reviewed and approved, ready to be published on the WFCC Web Site on December 1<sup>st</sup>, 2024.

## 4. WCCI Supervising Committee

A complete change of the Supervising Committee is required since current members (Mr. Marek Kolčak, Mr. Živko Janevski and Mr. Harry Fougiaxis) will not be in the position to fulfil the requirements in the 2022-24 cycle: Mr. Živko Janevski is hardly reachable since long time; Mr. Harry Fougiaxis will be a judge in this cycle; Mr. Marek Kolčak is planning to compete.

New members have been therefore appointed, and they kindly accepted the Task:

## 5. Any Other Business

## 5.1 Future of WCCI beyond the 2022-24 Cycle

We have briefly discussed within the WCCI Committee about the future of WCCI beyond the current 2022-24 cycle: is a change required (as it is the opinion of the Spokesman of the WCCI Committee), or should we maintain the "status quo"? But are there the conditions (notably a widespread support by the Countries Delegates and by the Composers' Community) to seriously consider and accept a change of the status quo (format and/or rules)?

Various options to possibly change the current WCCI format have been briefly reviewed, e.g.:

- Making WCCI a "by product" of FIDE Album (notably based on a straight average of the points scored by each Composer across the full set of entries submitted to the Album).
- Merging WCCI and FIDE World Cup into a new competition, possibly with a new format and/or an higher frequency than 3-years.
- Changing the composition of the judging panel of WCCI (while maintaining the basic format of the competition) with only 3 judges, completely shared with FIDE Album Judges.

Some initial discussion on pros and cons of various options has taken place, showing a diversity of opinions among WCCI Committee Members on the need for a change and on the viability of the various options. In front of such current diversity of opinions, the decision has been therefore to place the topic on hold, ready to restart discussions as soon as time for change will be more

mature. That said, however, the Spokesman of the WCCI Committee have underlined that a final decision on the topic is needed by the next WCCC the latest, i.e. before the beginning of the next WCCI 2025-27 cycle.

#### Report by the WCCT committee

As the spokesman Georgy Evseev was present only online, the report of the committee was presented by Kjell Widlert.

The committee had one meeting, with participants

Georgy Evseev (spokesman), over the phone Ofer Comay Harry Fougiaxis Peter Gvozdják Thomas Maeder Kjell Widlert

#### 1. Next WCCT

The 12. WCCT should normally be announced in the spring of 2025. Georgy Evseev had distributed a letter with a request to all WFCC members to provide the following information:

- is your country ready to provide a Director for the 12. WCCT?

- proposals of themes for the 12. WCCT

- in which sections are you ready to be a judging country?

The countries are asked to answer by **15 November, 2024**. Kjell Widlert stressed that without a Director, themes and judges, there will be no WCCT.

#### 2. Countries with sanctions

The committee had discussed whether countries with sanctions (at present Russia and Belarus) should be allowed to make a preliminary registration for the 12. WCCT, while still being able to actually participate only if the sanctions are lifted in time for the start of the tourney. The majority of the committee felt that there was no need for this: if and when the sanctions are lifted, a quick decision can be taken to allow those countries to take part.

#### 3. Change in score calculation

It is known that a judging country can have sone advantage for their own compositions by scoring compositions lower than they really merit. It is not known whether this is more of a theoretical problem, or a problem in practice.

A few years ago, David Hodge proposed a system to compensate for artificially low scores. This system has turned out to be hard to understand. Georgy Evseev has now proposed another system of compensation, which he regards as easier to understand. As the proposal came very late, the committee did not have the possibility to study it now, so the committee cannot recommend any change at this time (and therefore probably not for the 12. WCCT). The committee will return to the question next year.
